ADMISSION TO THREE YEAR B.A./B.SC./B.COM./B.B.A./B.C.A. (GENERAL) COURSE PART-FIRST, SESSION 2014-15

It is hereby notified for the information of all concerned that the admission to Part-First (**Annual Pattern**) of the Three Year **B.A./B.Sc./B.Com./B.B.A./B.C.A.** (General) Course for the academic session 2014-15 in the Govt./Private Degree Colleges affiliated to the University of Jammu falling under Winter Zone Colleges shall be made as under:-

In case the seats are available, the Principals may grant late admission on payment of late fee as under:-

The Vice-Chancellor may consider grant of late admission for one month only after the expiry of last date as per (b) above on payment of Rs.1630/- subject to the condition that wherever income of a candidate's parents is Rs.3630/- or below, she/he be exempted from payment of Rs.1630/-. However, late fee shall be charged in such cases as prescribed at 'b' above.

Admission in the above course shall be made irrespective of the holidays or vacations.

The regular teaching work of the class shall begin within a week after the close of admission (without late fee i.e. 22-05-2014).

Admission of students to Part-First of the Three Year B.A./B.Sc./B.Com. (General) Course shall be open to a person having passed the Higher Secondary Part-II (12th class) examination (in full subjects) of the Jammu and Kashmir State Board of School Education or an examination recognized as equivalent thereto subject to availability of seats. However,, a candidate who is placed under re-appear category only in one subject in Hr. Secondary Part-II (10+2 pattern) shall also be eligible to seek **provisional admission** in Govt. Colleges opened in 2005 onwards and Private affiliated colleges on his/her own risk and responsibility **subject to clearance of backlog within the prescribed chances.**

ELIGIBILITY FOR B.B.A. COURSE PART-I

Admission of students to the Three Year B.B.A. Part-First shall be open to a person having passed the Higher Secondary Part-II (12th class) examination (in full subjects) of the Jammu and Kashmir State Board of School Education or an examination recognized as equivalent thereto and has obtained at least 50% of the aggregate marks in the qualifying examination in case of General category candidates and 45% marks in case of SC/ST candidates. Provided that the admission in the Govt. Colleges shall be made directly by the admission committee of the college concerned on the basis of marks obtained by the candidate/s in the qualifying examinations & strictly as per other Statutes.

ELIGIBILITY FOR B.C.A. COURSE PART-I


Admission of students to the Three Year B.C.A. Part-First shall be open to a person having passed the Higher Secondary Part-II (12th class) examination (in full subjects) of the Jammu and Kashmir State Board of School Education or an examination recognized as equivalent thereto **with or without Mathematics** as one of the elective subjects and has obtained at least 45% of the aggregate marks in the qualifying examination in case of General category candidates and 40% marks in case of SC/ST candidates. Provided that the admission in the Govt. Colleges shall be made directly by the admission committee of the college concerned on the basis of marks obtained by the candidate/s in the qualifying examinations & strictly as per other Statutes.
